

## Authors' Responsibilities

"Costruzioni Metalliche" upholds rigorous ethical standards and requires authors to adhere to specific responsibilities to ensure the integrity and quality of published research. Below are the guidelines authors must follow when submitting manuscripts.

### 1. Originality and Plagiarism

- **Uniqueness of Submission:** Authors must confirm that their manuscript is entirely original and that it has not been published or submitted elsewhere, either in part or in whole.
- **Proper Citation of Sources:** If the manuscript includes material from other works, such sources must be clearly cited, and any text, data, or ideas from third-party works must be appropriately credited.
- **Avoidance of Self-Plagiarism:** Authors should not reuse substantial portions of their previous work without referencing, and any overlap with prior publications should be minimal and explicitly acknowledged.
- **Use of Plagiarism Detection Tools:** Authors are encouraged to use plagiarism detection software prior to submission to ensure originality and adherence to ethical standards.

### 2. Data Access and Retention

- **Data Retention Period:** Authors are expected to retain all relevant raw data and materials related to their research findings for a reasonable period after publication (generally at least five years).
- **Provision of Data on Request:** Upon request, authors should make their data available to editors or reviewers to verify the results and validate the integrity of their findings.
- **Compliance with Data Privacy:** If the data includes sensitive or personal information, authors must ensure that they have obtained appropriate permissions and have adhered to data privacy regulations.
- **Transparency in Data Sharing:** Authors should clarify any restrictions on data availability and provide supplementary materials or data sets where possible to support their findings.

### 3. Authorship of the Paper

- **Contribution Criteria:** Each author listed on the manuscript must have made significant contributions to the research, such as in the conception, design, execution, or interpretation of the study.
- **Approval of Final Manuscript:** All authors should review and approve the final manuscript before submission, ensuring full responsibility for the integrity of the content.
- **Order of Authorship:** The order of authorship should be a collective decision among the co-authors and should fairly represent their individual contributions to the work.
- **Responsibility of Corresponding Author:** The corresponding author holds additional responsibility for managing communication between the journal and co-authors and for ensuring that all authors agree with the publication and the responsibilities outlined here.

### 4. Disclosure and Conflicts of Interest

- **Transparency of Financial Interests:** Authors must disclose any financial relationships or interests that could influence the research outcomes, such as sponsorships, grants, employment, or ownership stakes.
- **Declaration of Personal Interests:** Any personal or professional relationships that could be perceived as influencing the research should be disclosed to maintain transparency.
- **Documentation and Communication:** Authors should include a conflict of interest statement within the manuscript, detailing any financial or other substantive conflicts that may impact the findings or interpretations.
- **Objective Reporting:** In cases where conflicts of interest exist, authors are expected to prioritize objective presentation of research findings, disclosing the nature of any potential influence on the study.

## 5. Acknowledgment of Sources

- **Crediting Previous Works:** Authors must properly cite previous studies, individuals, or organizations that have influenced or supported their research, providing complete and accurate references.
- **Acknowledgment of Non-Author Contributions:** Any individuals or organizations that contributed to the research in a supportive but non-authorship capacity (e.g., technical assistance, funding, data access) should be acknowledged explicitly in the manuscript.
- **Transparency in Collaboration:** For collaborative research, authors should ensure that each entity's contributions are clearly documented, fostering transparency about the roles of supporting institutions or individuals.
- **Proper Attribution of Third-Party Content:** If the manuscript includes content (e.g., data, images, or proprietary information) from third-party sources, authors should secure permission and provide appropriate credit to the original creators.
