## 1. Structure of the Editorial Board

# • Director Responsible:

 Responsible for overseeing the journal's strategic direction and maintaining high ethical standards in its operations.

#### Editor-in-Chief:

 Leads the editorial process, makes final publication decisions, and ensures all published work aligns with the journal's standards and mission.

#### • Editorial Committee

- Members: Composed of experts from prestigious institutions and organizations in Italy and abroad.
- Role: Advises on manuscript selection, assists with peer review, and provides specialized knowledge within their areas of expertise. The committee collaborates closely with the Editor-in-Chief to uphold the journal's academic quality.

### • Executive Editorial Committee:

- o **Members**: A group dedicated to supporting the editorial board.
- Role: Responsible for administrative and executive support, facilitating communication between the editorial board and authors, and managing operational aspects of the publication process.

#### • Scientific Committee:

- o **Members**: Includes prominent national and international researchers.
- Role: Provides high-level advice on editorial policies, suggests strategic improvements, and upholds the journal's scientific integrity by reviewing policies and guiding its academic direction.

### Secretary:

The secretary manages communication between authors, reviewers, and editors and handles key administrative tasks to ensure the smooth operation of the editorial workflow. Additionally, the secretary is responsible for overseeing sales, managing financial matters related to the journal, and handling economic issues associated with open access options, supporting the journal's accessibility and financial sustainability.
